August 18,1980-Monday

- Junior Review Board meeting with parents,Chief Ginnitti, Sponsor Clint Soemann Sr.,First Asst. Chief Allen, and Junior Delegate Tom Howe,and President John Ginnitti also.

August 25,1980-Monday

- Application approved by E.C.V.F.C. Executive Board.

September 2,1980-Tuesday

- Meeting of general membership at 20:00 hours,application voted on at 21:15 hours,and sworn in to the membership at 21:20 hours.Issued fire equipment at 22:30 hours.

September 3, 1980-Wednesday (18:05)

- First ambulance/first aid request

September 6,1980-Saturday (08:57,12:30)

- First alarm of fire,first working fire also.

September 9, 1980-Tuesday (19:00)

- Received training and certification for use of M.E.R.S. radio. (Medical Emergency Radio System)

October 15, 1980-Wednesday (19:00)

- Received C.P.R. certification upon completing course in Cardio Pulmonary Resuscitation.

November 14, 1980-Friday (20:29)

- Answered 50<sup>th</sup> alarm for 1980. (First Aid Request)

November 27, 1980-Thursday (19:10)

- Answered 15<sup>th</sup> alarm of fire, for 1980.

December 1, 1980-Monday (21:44)

- Answered 50<sup>th</sup> request for first aid for 1980.

December 22, 1980-Monday (19:00)

- Submitted application for senior membership with additional five dollar fee to Chief J.V.Ginnitti.

December 29, 1980-Monday (19:30)

- Application for senior membership accepted by E.C.V.F.C. Executive Board with approval of the Junior committee.
